CoHHO Educational Unit

1. Aims

This scheme is for foreign students in the Graduate School of Kyoto University who is eager to learn how we can solve global and local environmental problems based upon CoHHO (Connectivity of Hilltop, Human and Ocean). This scheme provides an opportunity to learn this field, and finally aims to develop and support people who will be globally active and can operate in the field and at policy levels. This fellowship is kindly provided by the Nippon Foundation.

2. Eligibility requirements

The applicant:

- ■must be a citizen of a country other than Japan.
- ■be (or will be) a Master course student of the participating Graduate Schools in Kyoto University.
- ■will take credits in CoHHO Educational Program in Kyoto University.

3. Number of fellowships

One per year

4. Duration of the fellowship

Up to 2 years, from entering the Master's Program to complete the Program. If you cannot complete the Master's Program within 2 years, the fellowship will be stopped at 2 years.

5. Value

¥190,000 per month paid quarterly (April, July, October, and January). The fellowship will not cover the entrance fee and the tuition fees in the Graduate School of Kyoto University. You have to pay them.

6. Application Process

 - b. Pledge
 - c. Recommendation letter from Professor/Associate Professor (list below) of the CoHHO Educational Unit.

- Write "Application for CoHHO Educational Program" in red letters on the front of the envelope.

7. Review process

All proposals submitted to CoHHO Educational Unit are reviewed by the fellowship panel. The outcome will be notified by e-mail as soon as possible. Proposal documents cannot be returned to the applicant.

8. Duty of fellows

- (1) Fellows must obtain a student visa to enter the Graduate School of Kyoto University, and take lectures of CoHHO Education Program.
- (2) Fellowship will be stopped if any of the following applies.
 - a. If you are not a student in the Master's Program of the Graduate School in Kyoto University.
 - b. If you are employed for regular working (more than 30 hours in a week) with receiving the Fellowship.
 - c. If your student visa is revoked.
 - d. If the evaluation panel of CoHHO Educational Unit judge that you are not fit for this fellowship.
 - e. When the fellowship encounters unavoidable circumstances to keep the fellowship.
- (3) When the evaluation panel judges the Fellow's behaviors and study conditions to be inconsistent with the Fellowship's aim, the Unit can require a full repayment of all previously distributed funds.
